






# Standards of Conduct

Agencies must ensure that all •STAFF, •CONSULTANTS, •AND VOLUNTEERS abide by the program's standards of conduct.




Staff, consultants and volunteers will respect and promote the unique identity of each child and family and refrain from stereotyping on the basis of gender, race, ethnicity, culture, religion, or disability.




Staff, consultants and volunteers will follow program confidentiality policies concerning information about:

children,
families,
and other staff members.




#### No child will be left alone or unsupervised while under the care of Head Start staff, consultants or volunteers.



Staff, consultants and volunteers will use positive methods of child guidance and


will not engage in corporal punishment, emotional or physical abuse, or humiliation.




In addition, staff, consultants and volunteers will not employ methods of discipline that involve •isolation,

the use of food as punishment or reward,
or the denial of basic needs.





## NAEYC Code of Ethical Conduct Ethical responsibilities to children:


- Our paramount responsibility is to provide: •safe,

- •and promoting health, self-awareness, competence, self-worth, and resiliency.




### Ethical responsibilities to families:

Families are of primary importance in children's development. (The term *family* may include others, besides parents, who are responsibly involved with the child.)


Head Start Family Service Credential has taught us that the family is who the family says it is.

Because the family and the early childhood practitioner have a common interest in the child's welfare, we acknowledge a primary responsibility to bring about collaboration between the home and school in ways that enhance the child's development.




# NAEYC Code of Ethical Conduct Ethical responsibilities to colleagues:

- and positive relationships are modeled.




## NAEYC Code of Ethical Conduct Ethical responsibilities to colleagues:

Based upon our core values, our primary responsibility in this arena is to establish and maintain settings and relationships that support productive work and meet professional needs.





Ethical responsibilities to community and society:


Early childhood programs operate within a context of an immediate community made up of families and other institutions concerned with children's welfare.

- Our responsibilities to the community are...
- to provide programs that meet its needs
- to cooperate with agencies and professions that share responsibility for children
- to develop needed programs that are not currently available



Ethical responsibilities to community and society:

Because the larger society has a measure of responsibility for the welfare and protection of children, and because of our specialized expertise in child development, we acknowledge an obligation to serve as a voice for children everywhere.
